

Pursuant to Articles 1,4 and 8 of the Law on Transmission of Electric Power, Regulator and Electricity System Operator in Bosnia and Herzegovina ("Official Gazette BiH", 7/02, 13/03, 76/09 and 1/11) and Articles 2 and 4 of the Decision on scope, conditions and time schedule of electricity market opening in Bosnia and Herzegovina ("Official Gazette BiH", 48/06 and 77/09), at the session of the State Electricity Regulatory Commission held on 6 November 2014 adopted

**RULES ON
AMENDMENTS TO RULES ON SUPPLY OF CUSTOMERS IN BRČKO DISTRICT
OF BOSNIA AND HERZEGOVINA WITH ELECTRICITY**

Article 1

The definition of '**Non-eligible (tariff) customer**' in the Rules on supply of customers in Brčko District of Bosnia and Herzegovina with electricity shall be deleted.

Article 2

Paragraph (2) of Article 5 shall be deleted.

Article 3

Article 6 shall be amended and read as follows:

*"Article 6
(Default Supply)*

- (1) Eligible household and small customers that do not choose their suppliers and do not conclude supply contracts may purchase electricity from the default supplier.
- (2) Default supply shall be performed as universal service and last resort supply."

Article 4

Paragraph (3) of Article 7 shall be deleted.

Article 5

Item h), Paragraph (2) of Article 10 shall be amended and read as follows:

"h) consumption category and tariff group to the which the customer belongs and billing elements of the group per tariff system for customers supplied under the universal service,".

Article 6

Paragraph (1) of Article 8 shall be amended and read as follows:

"The supplier of last resort shall take over the supply of customers that are not entitled to supply under the universal service, without any special request, if their supplier leaves the electricity market thus leaving them without the electricity supply and any form of protection."

Article 7

Paragraph (2) of Article 17 shall be amended and read as follows:

"The default supplier shall supply the eligible customer referred to in Paragraph (1) of this Article at the price of supply service as determined in accordance with the Methodology for setting tariffs for electricity supply under public service in Brčko District of Bosnia and Herzegovina."

Paragraph (3) of the same Article shall be deleted.

Article 8

Chapter V **PRICES AND COSTS OF SUPPLY**, shall be deleted.

The former chapters **VI SUPPLIER SWITCHING** and **VII INTERIM AND FINAL PROVISIONS** shall become chapter V and VI respectively.

Article 9

A new Paragraph (2) shall be added in Article 23 reading as follows:

“(2) As an exception to Paragraph (1) of this Article, tariffs for supply under the universal service shall be published and applied in accordance with the SERC decision.”

Article 10

Article 24 shall be amended and read as follows:

- “(1) The eligible household customers and small customers may use the right to freely choose their electricity supplier as of 1 January 2015.
- (2) The eligible household customers and small customers that are left without their suppliers shall be automatically transferred to supply under the universal service.
- (3) JP “Komunalno Brčko” shall be obligated to supply those customers that do not choose their supplier.
- (4) In case of supplier switching by the eligible customer, the new supplier shall be obligated to inform both the previous supplier and the distribution network operator in Brčko District BiH of the resulting change.”

Article 11

The wording in Paragraph (1) of Article 27: “Any household and small customer“ shall be replaced by the wording: “Any eligible customer that is not entitled to supply under the universal service”.

Article 12

These Rules shall enter into force on the eighth day after its publication in the “Official Gazette of BiH”, and shall also be published in the official gazette of the Brčko District of BIH.
