

Pursuant to Article 4.2. and 4.7. of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina (Official Gazette of BIH, 7/02, 13/03, 76/09 and 1/11), Article 33 of the Rule of Practice and Procedure of the State Electricity Regulatory Commission (Official Gazette of BIH, 2/05) and Article 49, paragraph (7) of the Licensing Rule – Consolidated Version (Official Gazette of BIH, 63/16), at the session held on 17 December 2024, the State Electricity Regulatory Commission passed a

## **DECISION**

### **ON THE CONTINUED USE OF THE LICENCE**

1. Legal person "ENNA Opskrba BH" d.o.o., Sarajevo, the holder of the temporary licence for performance of the international electricity trading activity, registration number 05-28-12-319-18/23 of 29 November 2023, continues to use the previously granted licence under the name "ENNA Next BH" d.o.o., Sarajevo, with the licence conditions remaining unchanged.
2. This decision shall come into force on the day of the adoption while the operative part of the Decision shall be published in the "Official Gazette of BiH" and the official gazettes of the Entities.

#### ***Statement of Rationale***

Legal person "ENNA Opskrba BH" d.o.o., Sarajevo, seated in Sarajevo, Tešanjaska 24a, is a holder of the temporary licence for the international electricity trading activity granted by the Decision of the State Electricity Regulatory Commission (hereinafter: SERC), number 05-28-12-319-17/23 of 29 November 2023, for the period from 30 November 2023 to 29 November 2025.

The licensee notified SERC of the change of the Company's name and the person authorised for representation by the document of 22 November 2024, which was registered under number 05-28-13-248-1/24, for the purpose of changing these data in the SERC's official records accordingly.

Notification of the change of data was also supported by the relevant documentation, and through an insight into the Decision on the change of data of the Municipal Court in Sarajevo number 065-0-Reg-24-004635 of 11 November 2024, it was established that the change of the company's name, the change of the name of the Company's founder and the person authorised for representation were entered into the court register. Instead of the previous name "ENNA Opskrba BH" d.o.o., Sarajevo, the name "ENNA Next BH", d.o.o. Sarajevo was entered accordingly.

Taking into account that a change of name, seat or address of a licensee is not considered a change of the licence pursuant to the Licensing Rule – Consolidated Version, and taking into consideration the fact the data changed have no effect on the licensee's legal status and continuous unhindered use of the licence by the same legal person, pursuant to Article 49, paragraph (7) of the Licensing Rule– Consolidated Version, it was decided as provided in the operative part of the Decision.

Pursuant to Article 9.2. of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina, proceedings may be initiated before the Court of Bosnia and Herzegovina against this decision by filing a lawsuit within 60 days of receipt thereof.
