

Pursuant to Article 4.2. and 4.7. of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina (Official Gazette of BIH, 7/02, 13/03, 76/09 and 1/11), Article 33 of the Rule of Practice and Procedure of the State Electricity Regulatory Commission (Official Gazette of BIH, 2/05) and Article 49, paragraph (7) of the Licensing Rule – Consolidated Version (Official Gazette of BIH, 63/16), at the session held on 14 January 2026, the State Electricity Regulatory Commission passed a

## **DECISION ON THE CONTINUED USE OF THE LICENCE**

1. The company “Interenergo” d.o.o., Sarajevo, the holder of the licence for performance of the international electricity trading activity, registration number 05-28-12-260-17/25 of 12 November 2025, continues to use the previously granted licence now under the name “Kelag International” d.o.o., Sarajevo, with the licence conditions remaining unchanged.
2. This decision shall come into force on the day of the adoption while the operative part of the Decision shall be published in the “Official Gazette of BIH” and the official gazettes of the Entities.

### *Statement of Rationale*

The company “Interenergo” d.o.o., Sarajevo, seated in Sarajevo, is a holder of the licence for the international electricity trading activity issued in accordance with the Decision of the State Electricity Regulatory Commission (hereinafter: SERC), number 05-28-12-260-16/25 of 12 November 2025, for the period from 1 January 2025 to 31 December 20230.

The licensee notified SERC of the change of the Company’s name by the communication of 25 December 2025, which was received under number 05-28-12-368-1/25, for the purpose of changing these data in the SERC’s official records accordingly.

Notification of the change of data was also supported by the relevant documentation, and through an insight into the Decision on the change of data of the Municipal Court in Sarajevo number 062-0-Reg-25-004839 of 20 November 2025, it was determined that the change in the name of the subject of the entry “Interenergo” d.o.o., Sarajevo was entered in the court register, with the new name being “Kelag International” d.o.o., Sarajevo.

Taking into account that a change of name, seat or address of a licensee is not considered a change of the licence pursuant to the Licensing Rule – Consolidated Version, and taking into consideration the fact the data changed have no effect on the licensee’s legal status and continuous unhindered use of the licence by the same legal person, pursuant to Article 49, paragraph (7) of the Licensing Rule – Consolidated Version, it was decided as provided in the operative part of the Decision.

Pursuant to Article 9.2. of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina, proceedings may be initiated before the Court of Bosnia and Herzegovina against this decision by filing a lawsuit within 60 days of receipt thereof.
