Pursuant to Article 4.2. and 4.7. of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina (Official Gazette of BIH, 7/02, 13/03, 76/09 and 1/11), Article 33 of the Rule of Practice and Procedure of the State Electricity Regulatory Commission (Official Gazette of BIH, 2/05) and Article 49, paragraph (7) of the Licensing Rule – Consolidated Version (Official Gazette of BIH, 63/16), at the session held on 26 June 2024, the State Electricity Regulatory Commission passed a

DECISION

ON AN EXTENSION OF USE OF THE LICENCE

- The Company "EFT Rudnik i Termoelektrana Stanari" d.o.o., Stanari, the holder of the license for performance of the international electricity trading activity, registration number 05-28-12-158-17/22 of 15 September 2022, continues to use the previously granted license now under the name "Elektrane Stanari" d.o.o., Stanari, with the license conditions remaining unchanged.
- 2. This decision shall come into force on the day of the adoption while the operative part of the Decision shall be published in the "Official Gazette of BIH" and the official gazettes of the Entities.

Statement of Rationale

The Company "EFT – Rudnik i Termoelektrana Stanari" d.o.o., seated in Stanari, is a holder of the license for the international electricity trading activity granted by the Decision of the State Electricity Regulatory Commission (hereinafter: SERC), number 05-28-12-158-16/22 of 15 September 2022, for the period from 1 November 2022 to 31 October 2027.

The licensee notified SERC of the change of the Company's name by the document of 12 June 2024, which was received on 18 June 2024 and registered under number 05-28-13-248-1/24, for the purpose of changing these data in the SERC's official records accordingly.

Notification of the change of data was also supported by the relevant documentation, and through an insight into the Decision on registration of Regional Commercial Court in Doboj number 60-0-Reg-24-000269 of 6 June 2024, it was established that the change of the company's name of the subject of registration "EFT – Rudnik i Termoelektrana Stanari" d.o.o., Stanari had been entered into the court register, by entering the company "Elektrane Stanari" d.o.o., Stanari instead of the mentioned company.

Taking into account that a change of name, seat or address of a licensee is not considered a change of the license pursuant to the Licensing Rule – Consolidated Version, and taking into consideration the fact the data changed have no effect on the licensee's legal status and continuous unhindered use of the license by the same legal person, pursuant to Article 49, paragraph (7) of the Licensing Rule– Consolidated Version, it was decided as provided in the operative part of the Decision.

Pursuant to Article 9.2. of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina, proceedings may be initiated before the Court of Bosnia and Herzegovina against this decision by filing a lawsuit within 60 days of receipt thereof.
