Pursuant to Articles 4.2. and 5.3. of the Law on Transmission of Electric Power, Regulator and Electricity System Operator in Bosnia and Herzegovina (Official Gazette of BIH, 7/02, 13/03, 76/09 and 1/11) and Article 36 of the SERC Rules of practice and procedure (Official Gazette of BIH, 5/05), at its session held on 20 November 2024, the State Electricity Regulatory Commission passed a

DECISION

ON APPROVAL OF THE RULES ON ALLOCATION OF CROSS-BORDER TRANSMISSION CAPACITIES

Ι

By this decision the following rules on allocation of cross-border transmission capacities are approved:

- Rules for annual and monthly auctions for allocation of transmission capacities on the border between the bidding zones of EMS AD Belgrade (EMS) and the Independent System Operator in Bosnia and Herzegovina (ISO BIH).

II

The rules referred to in point I of this decision, the approval of which was requested by the Independent System Operator in Bosnia and Herzegovina by its acts number 05-1774-1/24 of 13 November 2024, shall be published in the manner as defined by internal rules of the Independent System Operator in Bosnia and Herzegovina.

III

The Rules for intraday allocation of transmission capacities on the border between the control areas of the Independent System Operator in Bosnia and Herzegovina (ISO BIH) and the Montenegrin Electric Transmission System AD (CGES), approved by the Decision number 04-28-10-353-2/20 of 4 November 2020 (Official Gazette of BIH, 73/20), continue to apply as well as the following rules approved by the Decision number 04-28-9-292-2/21 of 17 November 2021 (Official Gazette of BIH, 73/21):

- Rules for daily auctions for allocation of transmission capacities on the border between the bidding zones of EMS AD Belgrade (EMS) and the Independent System Operator in Bosnia and Herzegovina (ISO BIH);
- Rules for intraday allocation of transmission capacities on the border between the bidding zones of the Independent System Operator in Bosnia and Herzegovina (ISO BIH) and EMS AD Belgrade (EMS);
- Rules for intraday allocation of transmission capacities on the border between the control areas / Croatian Transmission System Operator (HOPS) and the Independent System Operator in Bosnia and Herzegovina (ISO BIH).

IV

This decision shall enter into force on the day of its adoption and it shall be published in the Official Gazette of BIH and the official gazettes of the Entities and the Brčko District of Bosnia and Herzegovina.
